What started as an idea transformed into a 501(c)(3) nonprofit organization focused on transparency and accountability. Since then, CFGP has been working to become the leading resource for Catholic and faith-based philanthropy.

Our services ensure an investment in the future of our faith. We work with donors to manage their charitable funds, helping them choose investment opportunities that best meet their needs. Through our consulting services, CFGP helps parishes and Catholic organizations grow and sustain their important work. By assisting both groups, CFGP helps magnify the impact of Catholic ministries for the people of the Greater Philadelphia region.





ANNUAL REPORT 2019

Us we conclude an important year in CFGP's history and begin another, we're pleased to share some of our most memorable milestones with you.

In Fiscal Year 2019, we continued to grow our development consulting services, exceeding a total of \$110M raised for local Catholic institutions in just six years. In addition to building upon our existing partnerships with local parishes, we welcomed three new ones, and also established 13 new funds with donors. For the fifth consecutive year, we raised over \$10M for the Catholic Charities Appeal of the Archdiocese of Philadelphia, and raised more than \$3.3M for the Saint Charles Borromeo Seminary Appeal.

We feel incredibly blessed to have had the opportunity to work with so many impactful organizations and individuals over the last year. Without their commitment to the Faith, we couldn't do what we do, and we are forever grateful to be surrounded by so many dedicated clergy and lay people. This commitment was the inspiration behind why CFGP was created, and continues to guide our mission of growing philanthropy according to the teachings of Jesus Christ.

CFGP ensures all donor dollars are stewarded to the causes they care most about. It is our pleasure to share with you some of the remarkable organizations whose futures now look brighter because of your investment in them. Here are the organizations who received CFGP Grants this year.

#### **Faith in the Future Foundation**

Faith in the Future independently manages 17 Catholic high schools and the four Catholic Schools of Special Education within the Archdiocese of Philadelphia. CFGP's \$6,000 grant to Faith in the Future purchased new books in braille for the library at St. Lucy Day School for Children with Visual Impairments.

Mercy Career & Technical High School (MCT)

MCT serves students from North Philadelphia by providing project-based education to prepare them for life after graduation. Whether they decide to immediately enter the workforce to start their career, or continue their education, MCT provides a comprehensive, academic, career and technical school experience. CFGP awarded MCT with a \$6,898 grant used to purchase AED's and CPR certifications for students in their nursing program.

#### Gianna Center of Philadelphia

As a member of the National Gianna Centers, their new home in Philadelphia aims to provide general gynecologic care, natural family planning education and infertility services - all while honoring the sanctity of life, the dignity of women and the integrity of marriage. The Gianna Center was awarded a













\$6,000 grant from CFGP's Women in Philanthropy Leadership Fund to help purchase necessary medical equipment for their new location.

#### #GivingTuesday 2018

Building on the generous support of donors like you during 2017, we once again selected Mother of Mercy House as our official #GivingTuesday beneficiary of 2018. Mother of Mercy House is based in the Kensington and Allegheny section of Philadelphia. Their mission is to share the mercy of God's love with all, while enhancing the presence of the Church in their community. Fr. Liam Murphy and Sr. Ann Raymond Welte, alongside their staff members and volunteers, work to provide necessary resources to their neighborhood, including food, clothing and toiletries, but also spiritual healing and growth for those who are suffering.

#### School Security Initiative

Prior to our first granting cycle of 2019, CFGP identified an urgent need within our elementary and high schools surrounding school security. After much research and collaboration with our schools, CFGP awarded 9 grants for updated security technology to:

#### **CFGP Volunteer Days**

Saint John's Hospice, July 2018 - Our staff participated in its first-ever Volunteer Day at Saint John's Hospice last July! Saint John's is a residential shelter in Center City Philadelphia that serves more than 250 homeless men each year. The organization provides several life-saving services to these men, including case management, mail service, access to showers and clean clothing, and a safe place to sleep at night. All of our staff members took the afternoon to serve lunch and distribute clothing to the men served by Saint John's Hospice. We're so grateful for the opportunity to work with St. John's and their staff who are committed to changing the lives of those they serve.



Archbishop's Benefit for Children, **December 2018** - During the Christmas season, our team joined the staff at the Archdiocese of Philadelphia to prepare for the annual Archbishop's Benefit for Children Christmas party. Our staff helped stuff stockings for children and package goodies for the annual party. The Archbishop's Benefit for Children is a year-round fundraising intiative that supports underprivileged children from across the Greater Philadelphia region. Every year, their annual initiative culminates in a Christmas party in which all benefitting children are invited to attend and receive donated gifts.

#### Women in Philanthropy Luncheon

October 2018 - Our annual Women in Philanthropy Forum took a different approach last year. Instead of a panel discussion, we decided to host an award luncheon honoring a female philanthropist in our area. Our honoree was our dear friend, Dr. Rosalie Mirenda, President Emeritus of Neumann University. Dr. Mirenda was given CFGP's Love in Action Award, named for St. Teresa of Calcutta's famous quote. #### **CFGP Executive Series: Health Care Forum**











# The Catholic Foundation of Greater Philadelphia began the year with \$13,739,671 and ended the year with \$15,917,153.
